A copy of the licensee's State of Michigan Building License is REQUIRED (Registration Fee \$30). An original application with original signatures must be submitted for processing. **Self-addressed stamped envelopes must be submitted with all main-in permits** per section 23a of the State Construction Act of 1972, 1972 PA 230, MCL 125.1523A, prohibits a person from conspiring to circumvent the license requirements of this State relating to persons who are to perform work on a residential building or a residential structure. Violators are subject to civil fines.

HOMEOWNER PERMITS: Homeowners are discouraged from obtaining permits on behalf of a contractor. Code and Ordinance issues are enforced with a permit holder.
